Mayoral candidates oppose the ORBP by a 2-to-1 margin

Strong agreement on the East End Bridge, opposition to tolls on existing bridges and reversible lanes on the 2nd Street Bridge.

Louisville, KY – On April 19th, the attached Transportation Questionnaire was emailed to all twelve of Louisville's Mayoral candidates. The questionnaire consists of nine short, mostly YES or NO questions on a range of transportation topics. "Do you support the Ohio River Bridges Project?" "Would you support dividing the project?" Etc. All the candidate's answers have been compiled and their individual questionnaire responses will be posted online.

Here is a synopsis of the results:

Only one of the candidates opposed completing the East End Bridge before construction of the Downtown Bridge begins, as is currently planned according to the ORBP's last published construction schedule. That candidate was Independent Jackie Green, who is also the only candidate who doesn't support building any bridges.

Similarly, there was only one candidate who broke from the group when asked if they would support placing tolls on existing interstate bridges like the Kennedy and Sherman-Minton bridges. Only Democrat Greg Fischer said he could support such tolling.

When asked if they would support dividing the project into two sections (Downtown and East End) if it became necessary to pay for it, only Mr. Green and Democrat Jim King said NO. Mr. Fischer was non-committal, but all the other candidates said YES and that they would prioritize the East End Bridge.

When asked if the candidates support the ORBP's plan to relocate the 3rd Street ramp to the east, adjacent to the Waterfront Park playground, only Mr. Fischer and Mr. Tandy said YES.

Interestingly, all of the candidates support an initiative unrelated to the ORBP. They favor using reversible lanes on the 2nd Street Bridge – like on Bardstown Road and the Golden Gate Bridge – to improve bridge capacity. Though, Mr. Fischer's support was only implied, but non-committal.

Republican Hal Heiner was the only candidate whose campaign acknowledged that he refused to answer the questionnaire. Two candidates, Democrat Connie Marshall and Democrat Burrell Farnsley never responded to our questionnaire request.
